

SUMMER 2026 FINAL EXAM SCHEDULE

For courses having both lecture and recitation, the time of the exam will be determined from the time of the first lecture period of the week. For courses having recitation only, the exam will be determined from the first recitation period. Courses beginning at a time between two exam periods will be scheduled at the preceding hour: **(Using the Half Term Session I schedule below as an example, a class meeting Monday at 3:00 p.m. will use exam code letter "C" and similarly a class meeting Tuesday at 1:00 p.m. will use code letter "F")**. Students should receive notification from instructors as to the time and place of examinations. In general, exams will be held in the classroom where the class normally meets during the term. The instructor will arrange examinations for all one-month and mini-term courses. These exams should be held within one week after the end of the class. The final examination period is determined by the University Calendar Committee and approved by the Board of Regents.

- Final exam schedules can only be modified by the unanimous written and anonymously collected consent of the students enrolled in the course. Consent must be submitted to the Office of the Registrar no later than five (5) weeks before the last day of the term.
- Students with exam conflicts (two or more final exams scheduled at the same time) should contact the instructors for scheduling adjustments.
- Students with three or more exams scheduled in one day should seek alternate arrangements with the instructors before contacting Office of the Registrar. Accommodation must be arranged before the final day of the regular drop period for the term.

All final exams must be held within the structured final exam time blocks. No exams may be held on Study Day.
